GENERAL FUND FINANCIAL REPORT:

On a motion from Norma Craddock, seconded by Nick Sanders, the October 2022 General Fund Financial report was approved as submitted. Vote 5-0

WATER DEPARTMENT REPORT:

Water superintendent, George Spearing, III, didn't have much new news but that all wells were running good at the time. White's Run is pumping more. Working on a survey for iron in wells #6, 7, 8.

WATER FUND FINANCIAL REPORT:

On a motion from Jack Norman, seconded by Danny Morcom, the October 2022 Water Fund Financial Report was approved as submitted. Vote 5-0

FIRE DEPARTMENT:

Mr. Fleming was present to speak on behalf of the AVFD. They had a successful stew fundraiser. They sold out in an hour! They grossed about \$3500 & after expenses that left approximately \$2900. Mayor Spearing said he would talk w/Fire Chief Heath Baker for more details.

CODE ENFORCEMENT:

Lynn Shedd reported we did permits for a storage building & a power pole. He will also check on the limbs in Creekside again.

TSPLOST/LOST:

On a motion from Nick Sanders, seconded by Norma Craddock, the TSPLOST report was approved as submitted. Vote 5-0

OLD/NEW BUSINESS:

City clerk, Dana Player was present to give an update on the past due water bills. Past dues totaled around \$9000 last month & we are now down to about \$3500 past due. She started using the new collection letter to warn of cut-off dates & did have 9 cut offs but 6 paid in full.

Jack Norman confirmed the community wide Christmas party will be 12/10 @ 6pm. Heidi made invitations to insert with water bills to invite the public. We will also have several plaques to present.

Andy Barrs was present at the meeting to introduce himself & to meet the council, He has purchased the 112 acres on Arnoldsville Rd/Hwy 78. He discussed ideas with the council & what potential plans might be for that property but he is in no rush to build it out right now. Ideally, he wants this property to be a great resource for the county with maybe a store like Striplings or maybe a medical office on the Hwy 78 frontage. He wants to help add value to the city & the county. We discussed annexation & Norma Craddock was not interested in that but Jack Norman, Danny Morcom & Nick Sanders were in agreement with annexing the property. George Spearing shared we will need another well & they discussed using Rusty Allen about finding a new spot for one. Andy Barrs indictated the timber has been inventoried. Mayor Spearing said we will need to revisit zoning & ordinances & Andy is willing to work alongside of us to get those updates going.

City attorney, Danny Love, let the council know we will be needing a new insurance carrier. He has a guy working on it now but wanted the council to be aware of changes & we may have to meet in December to discuss a new insurance plan.
