Water Department Report

Water Superintendent, Adam Boswell, said that everything was going well. We had a sanitary survey done and there is work that needs to be done on the well house at Meyers Farm Road. Also, the dog houses on the well house need to be attached where they cannot be removed. Lynn Shedd turned in an estimate of \$2,100.00 for installing extra 2 x 4's in the wall, insulation, ½" treated plywood on the walls and the ceiling.

On a motion from Douglas Cosby, seconded by Joel Kriner, the estimate from Lynn Shedd in the amount of \$2100.00 for the Meyers Farm Road well house was approved. Vote 4-0

Adam reported that we received a failure to monitor the water system. He said that it was not our fault. They sent the bottles late. Notices will go out in the bills and will be posted on the door of City Hall.

Fire Department

The Arnoldsville Fire Chief, Heath Baker, was not present. Douglas Cosby said that they have had 80 calls so far this year and that the most they have had in a year was 120 since Heath started. They are on track for 160 this year. Monday, there was a house fire on Smokey Drive. Yesterday, they added smoke detectors to a home.

The Barbecue is October 25th. Also, they received one quote for the building and are waiting on a couple more.

Zoning

Land Use/Zoning Officer Lynn Shedd reported that it was quiet right now.

New Business

Mayor, Danny Morcom, asked the council if he could get quotes for the paving of the City Hall parking lot.

On a motion from Blake Arnold, seconded by Douglas Cosby, it was approved to get quotes for the paving of the City Hall parking lot. Vote 4-0

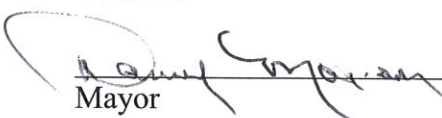
At 6:19 pm, on a motion from Joel Kriner, seconded by Douglas Cosby, the council went into an executive session. Vote 4-0
